

NOTICE TO BIDDERS

SEALED BIDS will be received by the Perrysburg Township Administrator of Perrysburg Township, Wood County, Ohio at the Township Office located at 26609 Lime City Road, Perrysburg, Ohio 43551 in said Office until **1:30 p.m. EDST on June 19, 2017**, for the performance of all labor and the furnishing of all materials, tools, machinery and appliances necessary for the construction of the **Bates Road Improvement** in accordance with the Plans and Contract Documents prepared by Proudfoot Associates, and at that time be publicly opened and read aloud. All bids shall be signed and enclosed in a sealed envelope marked "**Bates Road Improvement**" and addressed to the Perrysburg Township Administrator. Each bid shall contain the name of each person, firm or corporation interested in same and must be accompanied by either a bid bond to the satisfaction of the Perrysburg Township Administrator, or a certified check on a solvent bank, in the amount of ten (10%) percent of the amount of the Bid, made payable to Perrysburg Township as a guarantee that if the Bid is accepted, a Contract will be entered into and its performance properly secured.

The project consists of removal and replacement of approximately 17,170 square yards of asphalt pavement; miscellaneous pavement widening; stone berms; drive restorations; and new pavement markings.

The Plans and Contract Documents may be obtained from the office of Proudfoot Associates, **2005 Michael Owens Way, Perrysburg, OH 43551**, upon non-refundable payment of \$50.00. Plans and Contract Documents will also be on file at the Builders Exchange of Toledo, 5555 Airport Highway, Suite 140, Toledo, OH 43615.

Bidders must comply with the prevailing wage rates on Public Improvements in Wood County, Ohio, as determined by the Ohio Department of Commerce, Wage and Hour Bureau.

Bidders shall submit with this Bid the affidavit required under Ohio Revised Code Section 5719.042 that the bidder was not charged with any delinquent personal property taxes in Wood County, Ohio (Page AC-1 of Contract Documents) and the Affidavit required under the Ohio Revised Code Section 3517.13 (pages CC of Contract Documents).

Bids received after the scheduled Bid opening date and time, or not accompanied by a satisfactory Bid Bond or Check, will neither be read nor considered.

The successful bidder will be required to submit a Performance Bond, Maintenance Bond, and Certificates of Insurance.

Perrysburg Township reserves the right to reject any or all Bids, to waive any irregularities in any bid, and to accept any bid which is deemed to be the most favorable to Perrysburg Township. Perrysburg Township also reserves the right to add or subtract from the quantities shown in the proposal.

No bidder may withdraw his Bid for a period of sixty (60) days after the scheduled closing time for receipt of Bids.
